A transit visa may be required when connecting/transiting through certain countries. Please review your flight itinerary to ensure that needed transit visas have been obtained. Note: the issuance of a transit visa may take up to 10 business days.

Medical Insurance:

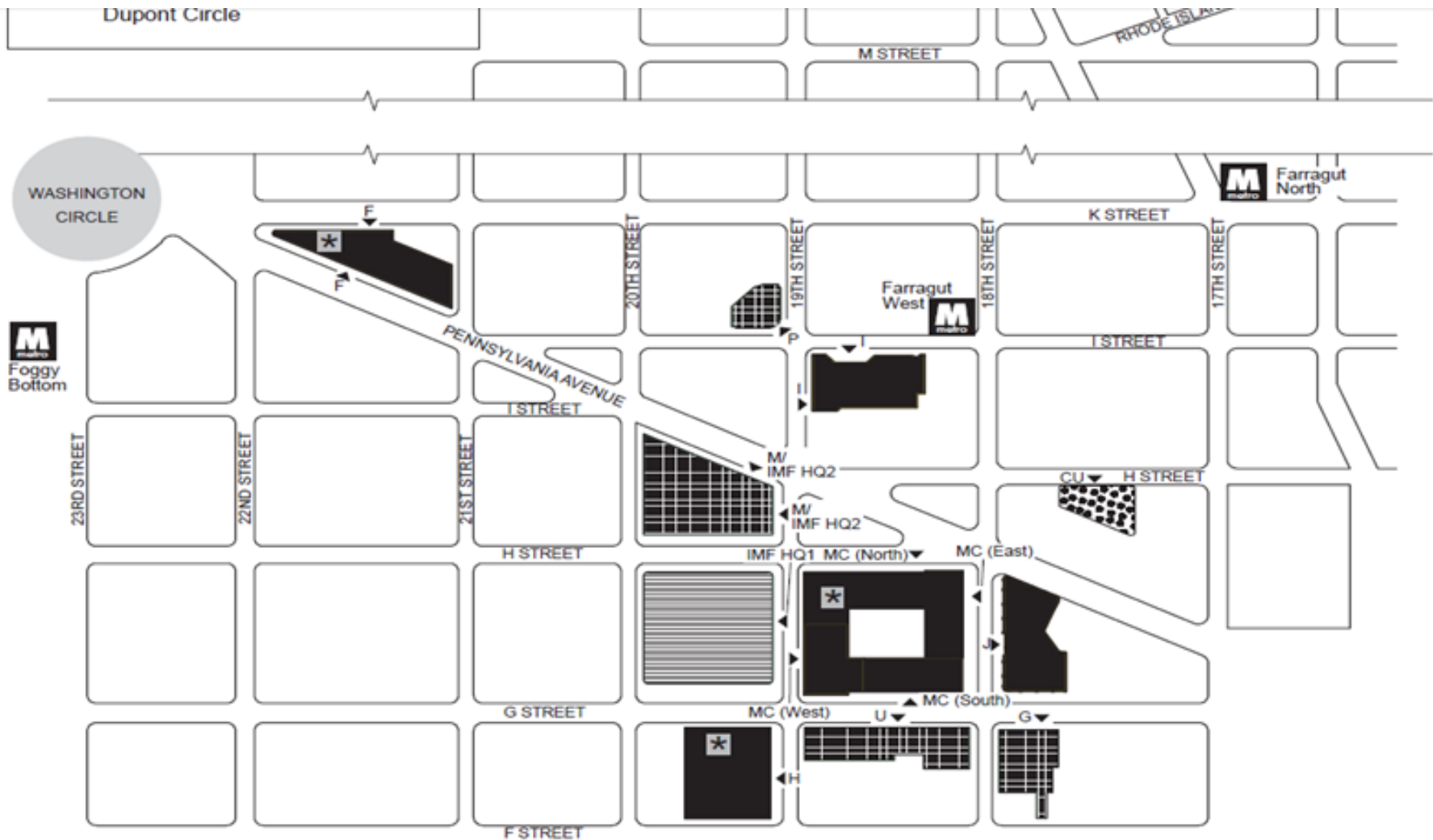
