Technical Mission

Terms of Reference (ToR) for working on the Draft FIP Investment Plan

September 12-16, 2011

A. Background

- 1. Lao PDR has been selected by the FIP Sub-Committee to be one of the eight pilot countries around the world. FIP supports the efforts of developing countries to reduce emissions from deforestation and forest degradation, conservation and sustainable management of forests, and enhancement of forest carbon stocks (REDD+). The Program promotes sustainable forest management leading to emission reductions and the protection of carbon reservoirs by providing scaled-up financing to developing countries for REDD+ readiness reforms and public and private investments, identified through national REDD+ readiness or equivalent strategies.
- 2. The Department of Forestry (DoF) within the Ministry of Agriculture and Forestry (MAF) has been appointed as the National REDD Focal Point on behalf of the government of Lao PDR (GoL). Multi-Development Banks (MDBs) namely the ADB, World bank and IFC will be provided technical input to the government in preparation of the FIP Investment Plan. In line with the Terms and Reference of the CIF and led by the GoL, the Scoping Mission was conducted on January 19-21, 2011 followed by the First Joint Mission which was undertaken from June 6-10, 2011. The aim of the First Joint Mission was to update and continue the dialogue with the line ministries and other key stakeholders from the private sector, MDBs, other development partners, Civil Society Organizations and NGOs on the updates of FIP guidelines (tentative allocations for each pilot country in grant and loan, knowledge management, result framework, and Dedicated Grant Mechanism) as well as discussing the potential areas for FIP investments.
- 3. A number of follow up meetings with key line ministries (REDD Task Force members) were held to discuss the priority areas for FIP investments and proposed investment plans on 16 August and 6 September 2011.

B. Objectives

4. This technical mission is aimed at having follow up discussions with the government at the central and provincial levels to solicit views for the finalization of the proposed FIP investment plan prepared by the government prior to submitting

C. Scope of the Mission

5. Lead by the Government of Lao PDR (GoL), the following activities will be undertaken as part of the Technical Mission:

- i. Participate in 2 consultation workshops which will be organized by the government to inform and consult with the provincial stakeholder on the draft FIP Investment Plan;
- ii. Discuss with the REDD Task Force members, CSOs/NGOs, ethnic group representatives (Lao Front for Construction, Ministry of Foreign Affairs, National Assembly) and key government representatives at the central and provincial levels on the draft proposed investment plan; and
- iii. Assist the GoL in reviewing the draft Investment Plan.
