**RESULTS FROM THE CONSULTATIONS FOR THE SELECTION OF SEATS
FOR THE CTF AND SCF TRUST FUND COMMITTEES
AND THE PPCR SUB-COMMITTEE**

Dear colleague,

1. I would like to take the opportunity to thank you for your active engagement in the selection of seats to the CTF and SCF Trust Fund Committees and the PPCR Sub-Committee. With this e-mail, I would like to summarize the selection process, inform you about the results and identify next steps.

Selection Process

2. In the margins of the 2010 CIF Partnership Forum, consultations were held on Wednesday, March 17, 2010, and Thursday, March 18, 2010, for the purpose of agreeing upon seats for the CTF Trust Fund Committee, the SCF Trust Fund Committee and the PPCR Sub-Committee. On March 17, contributor countries met as a group while eligible recipient countries met in six regional groups (Africa, East Asia, Europe and Central Asia, Latin America and Caribbean, Middle East and North Africa, and South Asia). On March 18, all countries convened to confirm the results of the consultations, and eligible recipient countries agreed, as a group, on the final selection of Members from such countries for CTF and SCF.

3. Within the contributor country group, it was agreed that countries may partner in a "twinning" arrangement to share one seat. The two partnering countries will agree how to rotate representatives to serve as the Member for the seat. The contributor countries also agreed, recognizing the possibility that additional contributors may wish to join the CIF, that they would review the distribution of contributor country seats on the Trust Fund Committees and the three SCF Sub-Committees at the Partnership Forum in 2011.

Results

4. The countries selected to identify representatives to serve as Members on the CTF and SCF Trust Fund Committees and the PPCR Sub-Committee are listed in the table below. The new member countries are highlighted in red.
