#### Dedicated Grant Mechanism for Indigenous Peoples and Local Communities

A **dedicated grant mechanism** has been established under the FIP to provide grants to indigenous peoples and local communities in country or regional pilots to support their participation in the development of the FIP investment plans, programs and projects.

#### The scope of activities eligible for support should include, inter alia:

- Securing and strengthening customary land tenure and resource rights and traditional forest management systems of indigenous peoples and local communities;
- The development of pilot project proposals by indigenous peoples and local communities and their implementation; and
- The involvement of indigenous peoples and local communities in monitoring and evaluation of forest activities, in conformity with relevant national laws and regulations

The grant mechanism is being designed by indigenous peoples and local communities through a series of regional meetings and one global gathering. The meetings took place as follows:

Accra, Ghana (Africa): Vientiane, Lao PDR (Asia): Lima, Peru (LAC): Sidney, Australia (Oceania): Bangkok, Thailand (Global): Washington, D.C, USA (Global): November 18 - 20, 2010 January 25-27, 2011 February 2-4, 2011 February 7-8, 2011 April 2011 May 2011

Enhancing synergy with other related initiatives, including the FCPF readiness activities
