AGENDA ITEM 1. OPENING

1. Ms. Mafalda Duarte, Head of the Climate Investment Funds (CIF) opened the Meeting of the Sub-Committee of the Pilot Program for Climate Resilience (PPCR).

AGENDA ITEM 2. ELECTION OF CO-CHAIRS

- 2. In accordance with paragraph 25 of the Rules of Procedure for Meetings of the SCF Trust Fund Committee, the Trust Fund Committee elects from among its members a representative from an eligible recipient country and a representative from a contributor country to serve as Co-Chairs of the Trust Fund Committee for a term of 18 months.
- 3. The eligible recipient countries elected Ms. Chitembo Chunga from Zambia to represent the eligible recipient countries. The contributor countries elected Ms. Elizabeth Lien from the United States to represent the contributor countries for this meeting, with the understanding that they may elect a different chair for subsequent meetings.

- 6. The PPCR Sub-Committee welcomes the analysis conducted by the CIF Administrative Unit, in collaboration with the MDBs and Trustee, on achievements and results, resource availability, pipeline review, and portfolio updates.

The Sub-Committee requests the CIF Administrative Unit to include options on how to improve the efficiency of SCF Trust Fund Committee and Sub-Committee meetings, for discussion at the next SCF Trust Fund Committee intersessional meeting, to be convened prior to the January 2020 Trust Fund Committee meetings.
- 8. The PPCR Sub-Committee will convene an intersessional meeting to discuss options for allocating available resources in the PPCR.

 - assessing, monitoring, and reporting interest rate risk exposures for all CIF programs.
