 - ❑ analytics

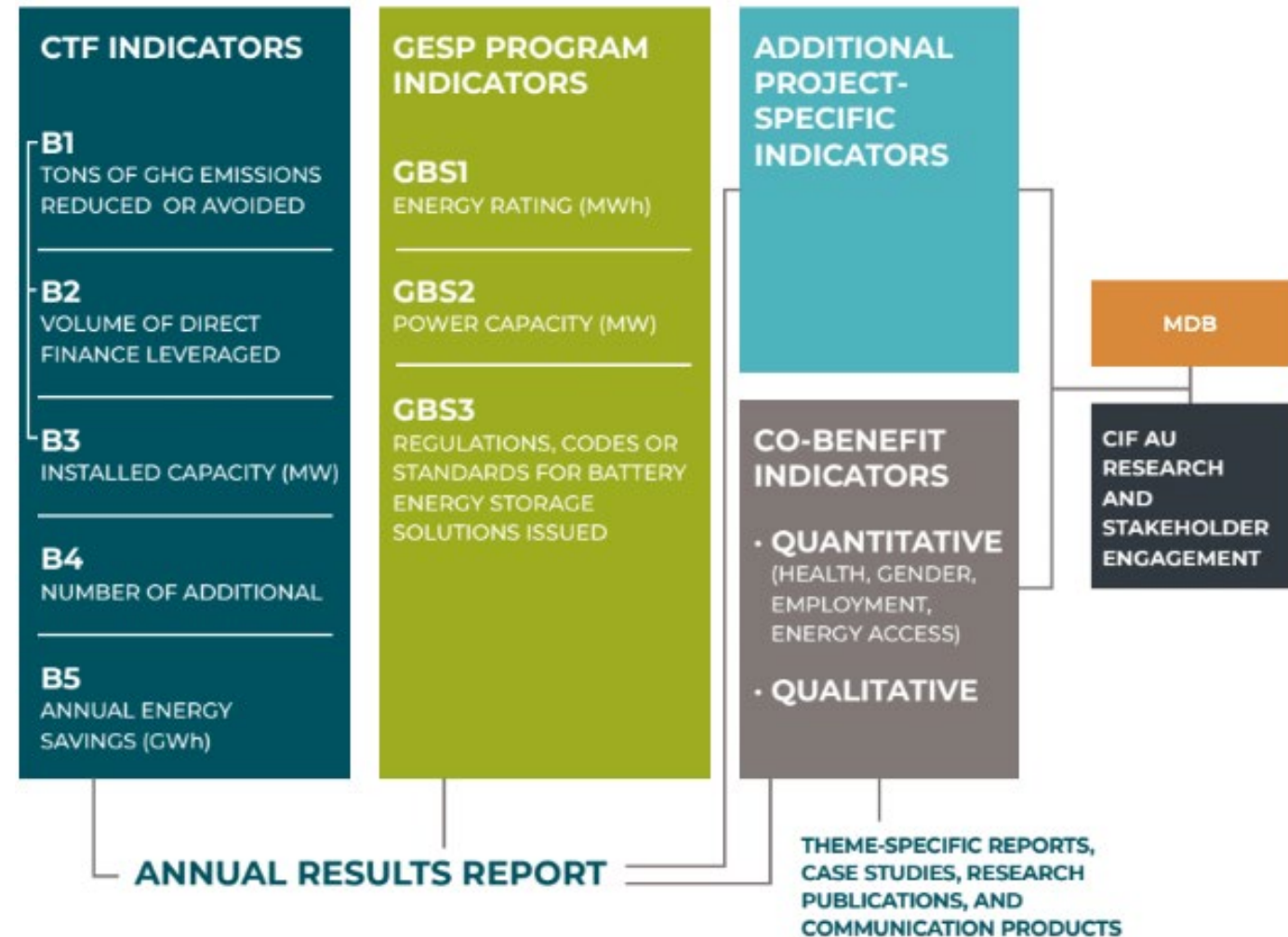
THE TOOLKIT: WHAT IS ITS PRIMARY PURPOSE?

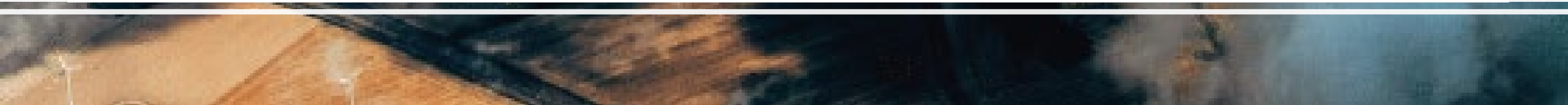
