AGENDA ITEM 1. OPENING

AGENDA ITEM 5. REPORT ON PIPELINE MANAGEMENT PROCESS AND CANCELLATION POLICY

- 6. At its last meeting in May 2015, the Trust Fund Committee requested the CIF Administrative Unit, in collaboration with the MDBs, to conduct a thorough review of the pipeline and to explore elements to be included in the existing pipeline management process.
- 7. The CIF Administrative Unit and the MDBs undertook several reviews of the CTF pipeline along with all existing guidelines and measures for pipeline management, and considered a number of new elements for a CTF pipeline management policy. It was concluded that more time is needed to reach a consensus among the MDBs. It was proposed that based on another around of pipeline review in early January 2016, a paper on CTF pipeline management policy

will be finalized at the end of January 2016 and will be circulated to the Trust Fund Committee for decision by mail.
