Participatory Management Project for REDD+ in Burkina Faso (AfDB)



- The CIF is collaborating with the World Bank Group's Development Impact Evaluation (DIME)
- Design of effective PES approaches— linear payments appear to outperform threshold payments both in terms of the absolute number and quality of surviving trees
- Linkages between conservation incentives & food security outcomes
- Innovative Dry Forest Mapping - precise data gathering is not only necessary but possible.

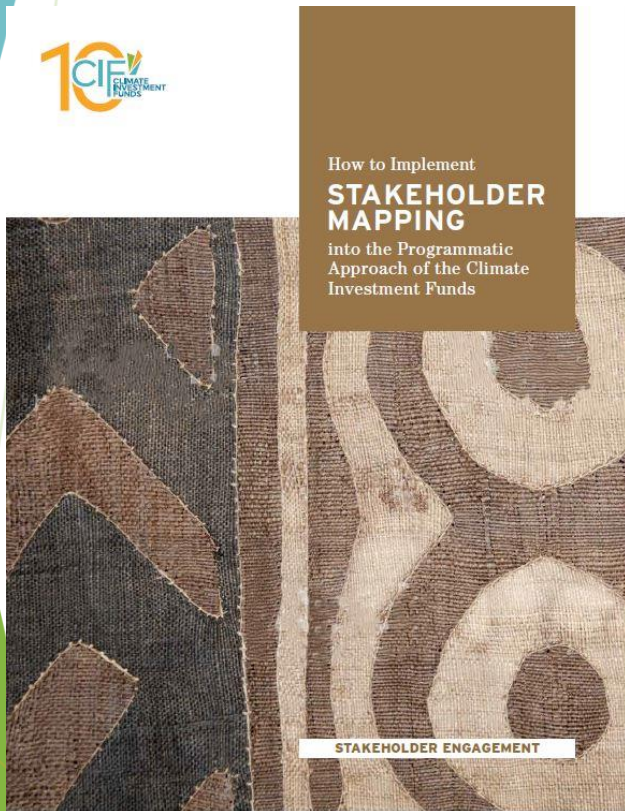
Led by the World Bank FIP team the case study provides a qualitative analysis of five key topics:

- Brazil FIP – using technology to broaden the identification & analysis process

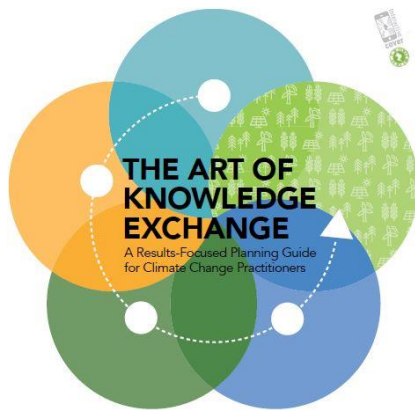


Art of Knowledge Exchange: A Results-Focused Planning Guide for Climate Change Practitioners

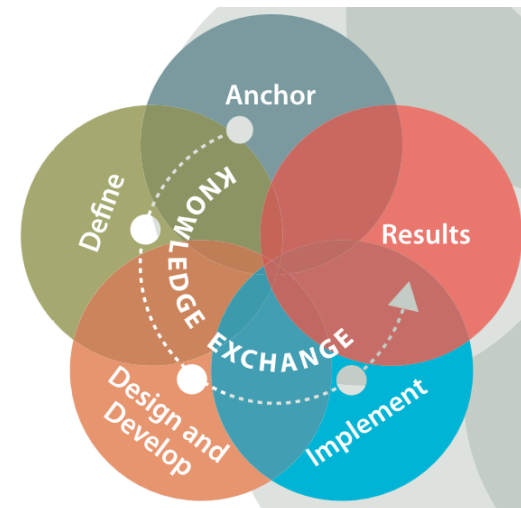

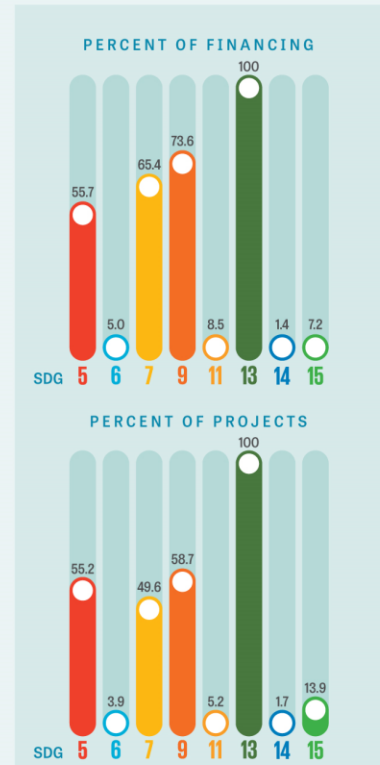
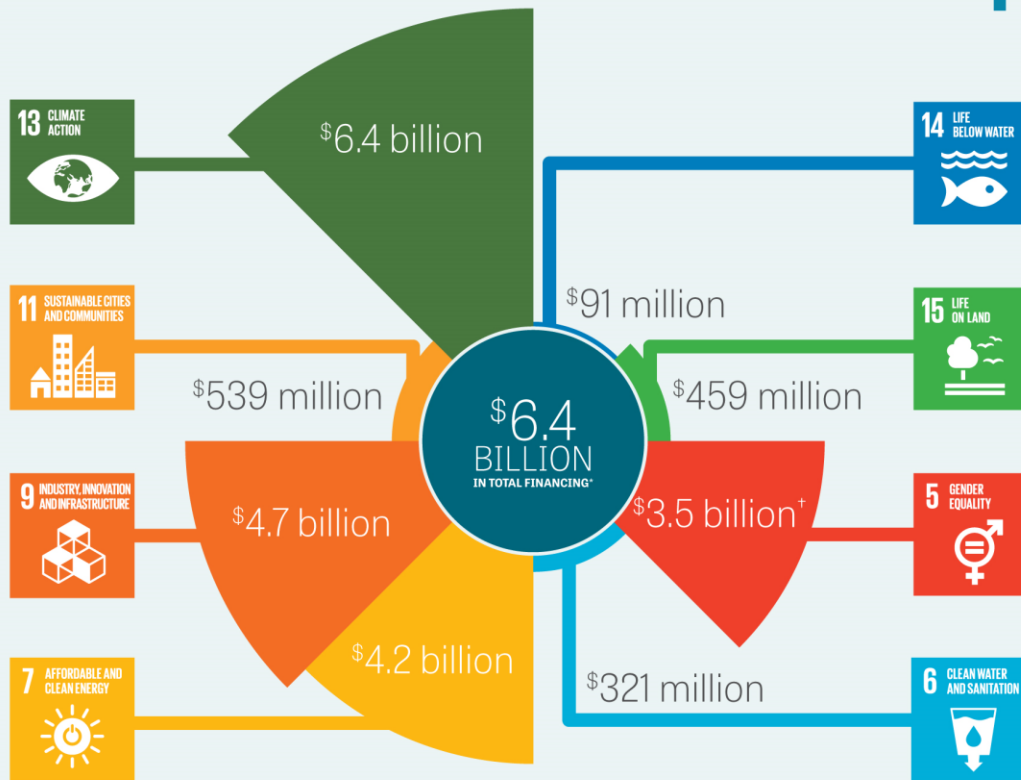
CIF Projects and the SDGs

CIF Projects and Sustainable Development Goals

To date, CIF projects have directly contributed towards eight of the 17 UN-Sustainable Development Goals.

CIF projects generally deliver additional benefits that go beyond the climate mitigation and adaptation scope.

CIF has successfully leveraged over \$45 billion in co-financing from MDBs, private sector and other sources that contribute to the SDGs.

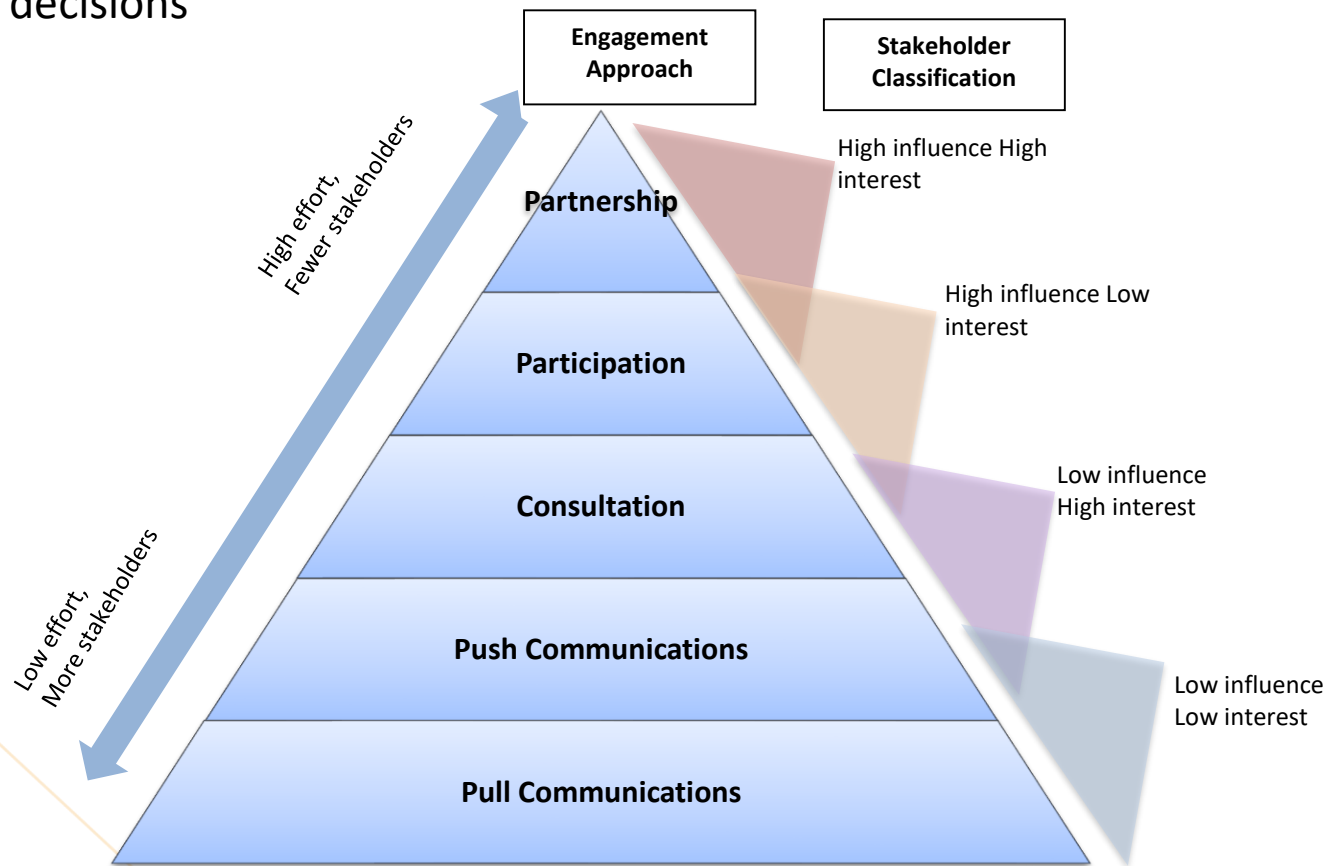
