1. Introduction

- 1. This semi-annual report provides an update as of December 31, 2018 on disbursements by the Climate Investment Funds (CIF), namely the Clean Technology Fund (CTF) and the Strategic Climate Fund (SCF), composed of the Pilot Program for Climate Resilience (PPCR), Forest Investment Program (FIP), and Scaling-up Renewable Energy Program in Low Income Countries (SREP). The report was prepared by the CIF Administrative Unit in collaboration with the multilateral development banks (MDBs). Further analyses on projects and pipeline tracking are presented in the June 2019 semi-annual operational reports (SAR) for each CIF program.
- 2. In this report, "disbursement" refers to CIF funds transferred by MDBs to recipient countries or private sector implementing entities. The disbursed funds tracked in this report are project funds and project preparation grants (PPG)¹. MDB Project Implementation and Supervision (MPIS) fees are not included as part of the disbursements. Guarantees are considered 100 percent disbursed once the guarantee product becomes effective and can be drawn by beneficiaries, regardless of actual transfer of funds.
- 3. The report begins with a review of disbursements at the aggregate CIF level and narrows down to CTF and SCF in Section 3 and Section 4, respectively. Each SCF program is analyzed separately in Sections 5 to 7. Disbursements in public sector projects per program are presented in the Annexes. Private sector projects are not presented due to confidentiality issues associated with the projects.

2. Over all CIF portfolio disbursements

- 4. As of December 31, 2018, CIF cumulative disbursements amounted to USD 3.16 billion representing 52 percent of the USD 6.1 billion funds approved by MDBs for projects. CIF total MDB approved funds, however, marginally decreased from USD 6.2 billion in the last semester mainly due to cancellations of some projects in CTF² that were more than approvals in the reporting period.
- 5. For the six months between July 1, 2018 and December 31, 2018³ (first semester of FY19) CIF overall disbursements increased by USD 253.3 million. Disbursements in the first semester of FY19 represent about 58 percent of previous year's total disbursements (July 1, 2017 June 30, 2018). Figure 1 and Figure 2 show a summary of the CIF portfolio of MDB-approved funds and the cumulative disbursements by CTF and SCF as of the end of the first semester of FY19.







Figure 3: Trends in CIF disbursement ratio

6. The CIF portfolio's aggregate cumulative disbursement ratio for MDB-approved funds reached 52 percent in December 2018 driven by increased disbursements across all programs. The CIF aggregate portfolio ratio was also enhanced, in part, by the decline in MDB board approvals in the CTF portfolio. Figure 3 shows the trend in CIF disbursement ratios since FY 11.

2.1 CIF disbursements by region

- 7. Projects in the MENA region, which represent approximately 10 percent of the aggregate CIF portfolio and are mainly CTF projects, had a combined disbursement ratio of 64 percent as of December 31, 2018. Four of the top six projects (by funds approved by MDBs) were fully disbursed as at the end of 2018. Most of the funding relates to the Ouarzazate Concentrated Solar Power Project which had fully disbursed USD 440 million as at the review date.
- 8. The Asia Region, which accounts for the largest share of CIF funding (approximately one third), disbursed 50 percent of MDB approved funds. In CTF, 28 percent of Asian projects had disbursed more than 75 percent of MDB approved funds, while 25 percent of projects in PPCR had disbursed more than 75 percent.


Figure 4: Share of disbursements in MDB approved funding per region⁵ (as of December 31, 2018)



2.2 CIF expected disbursement profile

9. It is expected that 93 percent of the undisbursed aggregate CIF MDB-approved funds shall be disbursed within the next five years. Only 7 percent of the funds shall be disbursed beyond the five-year timeframe. Figure 5 shows the expected trajectory of disbursements of outstanding MDB approved funds.

3. CTF portfolio disbursements

- 10. CTF's MDB-approved funds amounted to USD 4.21 billion. This includes MDB approvals and cancellations⁷ that occurred during the reporting period. Cumulative disbursements increased by 5.5 percent from USD2.21 billion to USD2.33 billion over this period.




Figure 6: Trends in CTF disbursement ratio

- 11. The increase in disbursements during the review period resulted in a significant increase in the disbursement ratio from 51 percent to 55 percent. Figure 6 shows CTF disbursement trends since FY11.

3.1 CTF disbursements by region




Figure 7: Share of disbursements in MDB approved funding per region (as of December 31, 2018)

12. As of December 31, 2018, projects in Latin America and the Caribbean Region disbursed 57 percent of CTF MDB-approved funds, while projects in the Asia Region had, in aggregate, disbursed 53 percent of MDB-approved funds. Projects in the Africa and Europe & Central Asia Regions had disbursed 62 percent and 39 percent of MDB approved funds, respectively. Figure 7 shows a breakdown of the cumulative disbursement by region.

13. Projects under CTF investment plans disbursed USD 2.3 billion as of December 31, 2018, while projects under CTF Dedicated Private Sector Programs (DPSP) disbursed USD \$50.7 million. Table 1 and Table 2 show a breakdown of investment plan and DPSP project disbursements by recipient country.

3.2 CTF expected disbursement profile




Figure 8: CTF expected disbursement profile9

- 14. As of December 31, 2018, 45 percent of CTF MDB-approved funds were undisbursed. Of these funds, it is anticipated that 93 percent shall be disbursed within the next five years. Only 7 percent of the undisbursed funds are outside the five-year timeframe of disbursements. Figure 8 shows the anticipated disbursement profile for CTF funds that are MDB approved.
- 15. The disbursement profile is based on MDBs' best estimates of their disbursement schedules. The estimates are informed by current information on projects in their portfolios.

4. SCF portfolio disbursements




Figure 9: MDB-approved SCF funds in June and December 2018 (in USD millions)

16. Disbursements under SCF programs increased by 17 percent from USD 770 million to USD 828 million, resulting in a cumulative disbursement ratio of 43 percent of MDB-approved funds. SCF aggregate MDB-approved funds increased by 6 percent from USD 1.8 billion to USD 1.9 billion during the first semester of FY19 (see Figures 9).





Figure 10: Trends in SCF disbursement ratio

17. The SCF aggregate disbursement ratio increased from 38 percent to 43 percent in the reporting period due to sustained increases in disbursements across all programs. Figure 10 shows the trend of the disbursement ratio since FY11.

- 18. As at December 31, 2018, SCF projects in Europe & Central Asia Region had disbursed 66 percent of funds approved by MDBs, while projects in Africa and Asia Regions had disbursement ratios of 42 percent each. Figure 11 shows the disbursement ratios by region.
- 19. Projects in Europe and Central Asia Region are mainly PPCR projects in Tajikistan and SREP projects in Armenia. As at December 31, 2018, more than 70 percent of the projects in Tajikistan were either fully disbursed or disbursed at least 80 percent of MDB-approved funds.





5. PPCR portfolio disbursements




Figure 12: Trends in PPCR disbursement ratio

20. Disbursements in PPCR increased by USD 85 million during the semester, resulting in a corresponding 20 percent increase in cumulative disbursements from USD 433 million to USD 518 million. MDB-approved funds marginally increased from USD 981 million to USD 985 million. As a result, PPCR's cumulative disbursement ratio increased from 44 percent to 53 percent during the reporting period. Figure 12 shows the trend in the cumulative disbursement ratio since FY11.

5.1 PPCR disbursements by region




Figure 13: Share of disbursements in MDB approved funding per region (as of December 31, 2018)

21. As of December 31, 2018, PPCR projects in the Asia and Africa Regions had disbursed 53 percent and 49 percent of MDB-approved funds, respectively. Projects in Latin America and the Caribbean Region disbursed 31 percent. Figure 13 shows a breakdown of share of disbursements in MDB approved funds by region. Disbursements in Europe and Central Asia are due to projects in Tajikistan.

22. Projects under PPCR Strategic Programs for Climate Resilience (SPCRs) disbursed USD 511.2 million as of December 31, 2018, while PPCR Private Sector Set Aside (PSSA) projects disbursed USD 7.2 million. Table 3 and Table 4 show a breakdown of SPCR and PPSA project disbursements by recipient country.

5.2 PPCR expected disbursement profile




Figure 14: PPCR expected disbursement profile

- 23. Undisbursed funds were 47 percent of MDB-approved funds as at December 31, 2018. Of these undisbursed funds, about 75 percent are expected to be disbursed within the next five years. Figure 14 shows the expected disbursement profile for PPCR outstanding funds.
- 24. The disbursement profile is based on MDBs' best estimates of their disbursement schedules based on current project information.

6. SREP portfolio disbursements

25. Disbursements in SREP increased by USD 22 million, from USD 82 million to USD 102 million during the reporting period.




Figure 15: Trends in SREP disbursement ratio

26. MDB-approved amounts increased from USD 408 million to USD 438 million during the reporting period. As a result, the disbursement ratio increased from 20 percent to 23 percent as disbursements grew faster than MDB approvals. Figure 15 shows the trend in the cumulative disbursement ratio since FY11.

6.1 SREP disbursements by region




Figure 16: Share of disbursements in MDB approved funding per region (as of December 31, 2018)

27. As of December 31, 2018, the Africa and Asia Regions disbursed 28 percent and 17 percent of MDB-approved funds, respectively. Ten out of 12 projects in Africa reported disbursements, with four projects having disbursed more than 70 percent of MDB-approved funds. These include the Menengai Geothermal project in Kenya, which disbursed 72 percent of MDB-approved funds. The Europe and Central Asia Region disbursement ratio is 68 percent due to one project in Armenia. Figure 16 shows a breakdown of disbursements by region.

28. Projects under SREP investment plans disbursed USD 95.7 million as of December 31, 2018, while SREP PSSA projects disbursed USD 5.9 million. Table 5 and Table 6 show a breakdown of SREP investment plan and PSSA project disbursements by beneficiary country.

7. FIP portfolio disbursements




Figure 17: Trends in FIP disbursement ratio

29. During the semester under review, FIP disbursements¹⁰ increased by USD 24 million, from USD 183 million to USD 208 million. The cumulative disbursement ratio, however, marginally decreased from 42 percent to 41 percent as MDB approvals grew faster than disbursements. Figure 17 below the trend in the cumulative disbursement ratio since FY11.

7.1 FIP disbursements by country

30. Projects under FIP investment plans disbursed USD 178.4 million as of December 31, 2018, while projects under FIP PSSA and the Dedicated Grant Mechanism for Indigenous Peoples and Local Communities (DGM) disbursed USD 10.4 million and USD 19 million, respectively. Tables 7, 8, and 9 show a breakdown of FIP investment plan, PPSA and DGM project disbursements by recipient country.

7.2 FIP expected disbursement profile

- 31. As of December 31, 2018, 59 percent of MDB-approved funds were not yet disbursed. Of these outstanding funds, approximately 97 percent is expected to be disbursed in the next five years. Only about 3 percent is outside the five-year timeframe. Figure 18 shows the expected disbursement profile for FIP.
- 32. The disbursement profile is based on MDBs' best estimates of their disbursement schedules based on current project information.
