SEMI-ANNUAL REPORT ON PPCR OPERATIONS

Proposed Decision by PPCR Sub-Committee

The PPCR Sub-Committee reviewed document, PPCR/SC.9/3, *Semi-Annual Report on PPCR Operations*, and welcomes the progress that has been made in advancing the work of the PPCR in the pilot countries and regions. The Sub-Committee notes with appreciation that SPCRs for most of the PPCR pilots have now been submitted for endorsement and are entering into implementation.

The Sub-Committee invites those pilots that have not yet submitted their SPCRs to continue to work expeditiously to prepare high quality programs.

Introduction

- 1. The purpose of this note is to provide the PPCR Sub-Committee with a semi-annual report on the status of PPCR activities. This is the third operational report presented to the PPCR Sub-Committee, and it covers the period from June 30, 2011 to October 31, 2011.
- 2. As PPCR has moved into its operational phase, the semi-annual report will increasingly provide data and information on meeting key benchmarks which are indicators of progress in the PPCR pilot countries, including dates on :
 - (a) Endorsement of SPCRs;
 - (b) projects and programs approved by the Sub-Committee;
 - (c) projects and programs approved by the MDBs;
 - (d) effectiveness of a project or program (signature of grant or loan agreement between the pilot country government and the MDB); and
 - (e) first disbursement.
- 3. This data will be provided through the SCF pipeline management system¹, which captures all relevant data for the SCF targeted programs, including the FIP. An important objective of pipeline management is to contribute to the effectiveness and efficiency of the SCF and its targeted programs by providing predictability and confidence in the management of the funds to the Sub-Committees as well as the country teams that are responsible for preparing investment plans and associated programs and projects.
- 4. The semi-annual report will also be complemented over time with information from annual monitoring reports which will reflect on the progress of projects and programs in the pilot countries and regions.

STATUS OF PPCR COUNTRY AND REGIONAL PILOTS

Strategic Programs for Climate Resilience

6. During its June 2011 meeting, the Sub-Committee reviewed and endorsed the SPCRs for Cambodia, Mozambique, Nepal, St. Lucia and Zambia, and agreed to the further development of activities foreseen in them. A total of US\$207 million in grant resources and US\$159 million in PPCR credits were requested for the development and implementation of identified priority actions.

- 7. SPCRs for Bolivia, Jamaica, Yemen and the regional track for the Carribbean program have been submitted for review and endorsement by the PPCR Sub-Committee at ist November meeting. If endorsed, all single pilot countries will have completed their programming process and will now be preparing projects and programs agreed in the endrosed SPCRs.
- 8. The remaining PPCR pilot countries, Dominica and Haiti, participating in the Carribbean regional program and Papua New Guinea and Tonga, participating in the Pacific regional program as well as the Pacific regional track are in the process of finalizing their SPCRs for submission in 2012.

Project Preparation Grant Approvals

9. During the reporting period, the Sub-Committee approved a project preparation grant in the amount of US\$ 600,000 in PPCR funding to contribute to the preparation of the *Bangladesh* - *Climate Resilient Infrastructure Improvement in Coastal Zone Project (ADB)*.

Project Approvals


- 10. During the reporting period, the PPCR Sub-Committee reviewed and approved PPCR funding two projects:
 - (i) Bangladesh Climate Change Capacity Building and Knowledge Management (ADB), with a PPCR grant allocation of US\$0.5 million.
 - (ii) Niger Community Action Project for Climate Resilience (CAPCR) (WB), with a PPCR allocation of US\$63.0 million (US\$35.0 million in grants and US\$ 28.0 million in credits).
- 11. As of October 15, 2011, PPCR funding for five projects have been approved by the Sub-Committee totaling 98.1million in PPCR resources. These resources are expected to leverage a total of US\$72.1million in co-financing.
- 12. Annex 1 provides an overview of the approved and endorsed PPCR resources by pilot country and region.

Monitoring for delivery of investment plans, projects and programs

13. The following "traffic light" system was agreed upon to flag for the PPCR Sub-Committee the delivery status of investment plans, projects and programs:

Green	MDB(s) confirms that delivery dates will be met or delays will not exceed
	12 months.
Yellow	MDB(s) acknowledges delays between 12 and 24 months but is reasonably
	confident that no further delays will occur.
Red	MDB(s) acknowledges delays of more than 24 months with uncertainties
	whether delivery will occur within 2 years of first anticipated delivery date

- 14. Since the PPCR Sub-Committee has begun to approve PPCR funding for project and program proposals which will be further developed by the countries and the MDBs, the traffic light system has been extended to capture the following additional benchmarks:
 - (a) date of PPCR Sub-Committee approval
 - (b) date of MDB approval,
 - (c) date of signature of project agreement between the MDB and the Government of the pilot country or other client; and
 - (d) date of first disbursement.
- 15. For these benchmarks, the "traffic light system" is as follows:



- 16. The table below presents for each pilot country comprehensive information on
 - (a) dates for submitting SPCRs to the PPCR Sub-Committee for endorsement;
 - (b) dates for submitting requests for approval of PPCR funding for a project or program;
 - (c) rating applying the traffic light system; and
 - (d) if applicable, reasons for delay and corrective measures to avoid further delays in submitting the investment plan, project or program to reach agreed benchmarks.

Disbursments

17. Consistent with the decision by the PPCR Sub-Committee, a second PPCR disbursement report was submitted to the Sub-Committee on August 30, 2011. The report is posted on the CIF website
