### **SREP State of Play**


- Endorsements of IPs: 20 investment plans and 7 PSSA concepts
  - June 2018: Madagascar
  - **December 2018**: Kiribati, Zambia
  - Uncertain: Benin, Malawi, Sierra Leone, Yemen
- Funding approvals: USD 502 million for 39 projects (as of December 31, 2017)
  - USD 548 million for 44 projects (as of April 30, 2018)
- Projects approval:
  - Six projects approved by SC during the reporting period (USD 96 million)
    - Approval ratio at 74% (as of December 31, 2017)
  - Another five projects approved afterwards (USD 45 million)
    - Approval ratio at 81% (as of April 30, 2018)
- Stocktaking review of SREP M&R system

- ➤ 6 projects totalling USD 53 million grant and USD 1 million non-grant
- The projects are placed in the reserve pipeline due to shortage of grant.

### Not under active development




### Headroom for including new projects in the sealed pipeline

- PPGs were already set-aside.













# **Co-financing Sources and Ratio**
