Honduras – First Joint Mission

For the formulation of the Strategic Program for Climate Resilience (SPCR) in the context of the Pilot Program for Climate Resilience (PPCR)

Government of Honduras (GoH) – Multilateral Development Banks (MDB)¹

1. Summary of activities

2. Specific objectives, results, and processes

Specific objectives:

One of the key objectives of the mission will be to reflect on the main impacts of climate variability and change on the social and economic development of the country. From there, and based on previous experiences and lessons learned, the mission will identify strategic actions to promote an enabling environment for climate resilience, including institutional, regulatory planning, budgetary and financial aspects.

Specifically, it is expected that the following objectives will be achieved during the mission:

- (i) Strengthen the National Climate Change Strategy, and government leadership through broad participation in relation to climate resilience in Honduras;
- (ii) Evaluate the activities, programs, and projects that have been completed, are ongoing or under preparation that address climate change adaptation (CCA), analyzing their

- achievements and challenges;
- (iii) Confirm the priority sectors and agree on possible preliminary actions or activities to be included as part of Phase I of PPCR², through consultations and the exchange of experiences, with specific consideration to the perspective of the most vulnerable groups;
- (iv) Identify, through specified criteria, the necessary CCA activities in the sectors that have major implications for country-wide development; and
- (v) Agree on the scope, cost, and the necessary institutional arrangements for the formulation of the SPCR.

Under the coordination of the GoH, an initial 3-day workshop will be held; from which, input and recommendations for priority actions needed for climate resilience (as a part of the SPCR) will be sought and organized according to priority sectors. This workshop is expected to include the participation of government agencies, development partners, NGOs, civil society organizations, academia and research institutes, representatives from vulnerable communities and groups (including a focus on gender issues), and the private sector, among other key stakeholders.

The workshop will include presentations of the key findings and recommendations from the process of formulating the National Adaptation Plan, as well as targets and indicators on climate resilience included in the **National Development Plan** (Country Vision), the **National Climate Change Strategy**, Honduras' "Intended Nationally Determined Contribution (INDC)³, and other existing, sectoral planning instruments.

The SPCR is envisioned as a strategic document that strengthens and is articulated with the National Climate Change Strategy and the National Adaptation Plan (under development).

Subsequently, it is expected that different stakeholders will reflect on the impacts of climate change and climate variability on their sectors and livelihoods, and how these impacts affect the goals and processes of national, sectoral, and territorial development. Next, the various groups of stakeholders are expected to contribute – from their own vision and experience – specific recommendations regarding the following structural axes of the SPCR:

- Institutional strengthening and strengthening of the legal/ policy framework on climate change (Facilitator: MiAmbiente DNCC)
- Improved knowledge and understanding of risks and processes for monitoring, analysis, evaluation, and alert/early warning systems (Facilitator: COPECO)
- Food security and resilient agriculture (Facilitator: SAG)
- Water security, including integrated water resource management and water & sanitation (Facilitator: MiAmbiente DGRH + SANAA)

The workshop will analyze in detail the processes to date in each of these sub-themes and will help

to establish the strategic actions to be taken in order to meet the objectives set out in the various planning instruments, as well as identify any information gaps that threaten or impede their implementation.

Further, the workshop will be used to analyze lessons learned from projects that have previously been completed, including those financed with the support of international development partners.

Expected results and outputs:

The expected outputs of the First Joint Mission are:

- A participatory analysis of the inter-relationships between the various climate change initiatives and the establishment of a coordinated approach to the development of synergies between them:
- A proposal of strategic activities to be undertaken in the preparation phase of the SPCR;
- A work plan for the formulation of the SPCR, including processes for development, deadlines, and deliverables, and responsible parties; and
- A proposal for inter-institutional coordination for the formulation of the SPCR

Organization of the mission:

The First Joint Mission for the PPCR will be held from March 8 to 16, 2016 in order to initiate the formulation of the Strategic Program for Climate Resilience (SPCR). The Mission will comprise a broad consultative process, including dialogue with government actors and NGOs; an analysis of plans, policies, and strategies for adaptation and country risk management; and analysis on the transformative actions to be implemented in the context of the National Development Plan, the National Climate Change Strategy, the National Adaptation Plan, and INDC, among others.

The mission will work to establish a platform for coordinated work among development agencies, the private sector, NGOs, and government agencies with the aim of formulating a strategic approach to intervention. The SPCR, and its respective portfolio of priority investments, will focus on promoting the integration of climate resilience into development planning processes at both the national and sectoral levels.

The International Finance Corporation (IFC), as part of the World Bank Group, will participate in the joint mission in order to provide input from the perspective of the private sector. This will help to consider both the impacts of climate risks posed to this sector, as well as the opportunities arising from the processes of adaptation and climate resilience.

Following the First Joint Mission, an aide memoire will be prepared to include key agreements reached, and a detailed work plan for the design and implementation of the SPCR. The GoH will lead and coordinate the mission with the support of multilateral development banks (IDB, World Bank and IFC).

The mission will include the following activities:

Inter-institutional workshop: March 8 – 10, 2016

- Presentation and analysis of the regulatory framework and of the key planning tools for climate resilience and risk management (National Development Plan, National Climate Change Strategy, National Adaptation Plan, among others).
- Discussions at national and sectoral levels, and on specific climate vulnerability issues, information gaps and investment needs.
- Search for consensus among different participating stakeholders on priority activities to be included in the SPCR.
- Analysis of ongoing or planned programs and projects on climate resilience financed by public funds, the private sector or international development partners (including the MDBs): main outcomes, lessons learned and proposals for investment opportunities.

Field visit: March 11 & 12, 2016

- Field visit to selected municipalities to obtain local information on climate risks in the country, and to undertake interviews and consultations with local authorities and community leaders.

Focus group meetings: March 14 – 16, 2016

- Further consultations with representatives of priority sectors in order to clarify the scope and details of the proposed activities.
- Meetings with the PPCR and FIP focal points for the preparation of the TA proposal for PPCR Phase I

3. Background and Introduction

Based on the expression of interest by the Government of Honduras (GoH) to participate in the PPCR in March 2015, the Expert Group recommended that the Climate Investment Funds (CIF) nominate Honduras as eligible to receive up to US\$ 1.5 million for the formulation of a SPCR.

The expression of interest by the GoH was approved by CIF on June 1, 2015, and in November 2015 a scoping mission was carried out to analyze the objectives and the intervention areas of the PPCR program for Honduras, as well as the institutional arrangements required for the preparation of the SPCR.

The GoH has committed to promoting the integration of climate change adaptation (CCA) and the reduction of risk in its national and sectoral development processes. As such, the PPCR program represents an opportunity to activate and strengthen the various existing committees and subcommittees related to climate change, food security, water resources, disaster risk management, and CCA. In particular, it is expected that the PPCR will encourage further modernization and regulation of the Law on Climate Change, as well as boost and consolidate the Inter-institutional Committee on Climate Change, which was created by the aforementioned law in November 2014.

The PPCR also provides an opportunity to develop a strategic framework for action, which would be expected to strengthen the National Climate Change Strategy and the National Adaptation Plan, which is currently being developed.

At the international level, the PPCR is expected to boost the existing cooperation efforts of the donor roundtable, which formed around the issues of climate change and risk management. The donor roundtable has been supporting the GoH on various programs and projects. Thus, there exists the opportunity for the PPCR to help guide the actions of not only the participating MDBs, but also of other development partners.

In this context, the SPCR is a leveraging tool for resources to support Honduras mainstream climate resilience, as a PPCR-participating country.

General Objectives of the PPCR: To help developing countries integrate climate resilience into development planning, including urban / infrastructure development; agriculture and food security; land and ecosystems; public policies; and institutional development/strengthening, based on national adaptation plans, and other existing efforts.⁴

Areas of Intervention of the PPCR in Honduras According to the Expression Interest:

- Strengthening meteorological knowledge management, water resources, and climate data in order to inform decision making. Increased capacity to develop climate change scenarios for Honduras, strengthening of climate information services through a comprehensive approach to provide timely information for agriculture, urban planning, and risk management, among others; and improved monitoring and forecasting, and more accurate early warning systems of extreme weather events. Effective coordination and exchange of interagency information. Development and dissemination of knowledge products.
- Institutional strengthening and human resources capacity building. Increased capacity to integrate climate change into national and sub-national development plans. Adequate availability of policies, procedures, guidelines, and institutions able to perform their functions holistically and sustainably. Improved coordination and exchange of information on national projects and projects funded by development partners, to avoid duplication of efforts.
- Resilient water resource management through the strengthening of water governance, integrated water management, knowledge generation/sharing, and multiple-use water infrastructure investment. Strengthening coordination mechanisms and governance among actors and users of the different sectors of water management. Optimization of water use in terms of reduced availability, development of studies for prioritizing storage infrastructure, and multi-purpose reservoirs.
- Agriculture and food security. Increased capacity of project beneficiaries to deal with / adapt to climate variability and change; complement existing investments through projects of the Alliance of the Dry Corridor; and support the replication and expansion of existing practices that contribute to improved food security through the management of crop varieties tolerant to drought and climate variability, which are effective management practices that will ensure that climate resilience becomes an integral part of land management and agricultural production.

Improved storage mechanisms, crop diversification, and water harvesting, among other practices proposed as part of the PPCR in Honduras.

4. Progress to date

Preparatory meetings and videoconferences: between September and November 2015, MiAmbiente organized a series of thematic meetings and preparatory videoconferences for the scoping mission.

Scoping mission: During November 9-11, 2015, a scoping mission was held jointly for the PPCR and the Program Forest Investment (FIP), along with participation from the World Bank, the International Finance Corporation (IFC), and the Inter-American Development Bank (IDB). The results of the scoping mission were as follows:

- a) The main issues identified in the expression of interest, which were risk awareness, capacity building, agriculture and food security, and water management, were confirmed as the key areas to prioritize for the SPCR
- b) Discussion groups were formed in connection with priority issues to elaborate on the analysis of information gaps, key stakeholders, and strategic activities.
- c) The existing inter-institutional coordination mechanisms (at government level) were analyzed to identify the most adequate mechanisms to support the formulation of the SPCR.
- d) Lessons learned from other countries regarding the formulation and implementation of the SPCR were analyzed.

The scoping mission was attended by 71 delegates from 22 institutions, including the Ministry of Energy, Natural Resources, Environment, and Mining (MiAmbiente), the Ministry of Finance (SEFIN), the Ministry of Infrastructure and Public Services (INSEP), the Ministry of Agriculture and Livestock (SAG), the Permanent Commission of Contingencies (COPECO), the National Autonomous Service of Aqueducts and Sewers (SANAA), and the Forest Conservation Institute (ICF), among others. Preparatory activities ahead of the Joint Mission

MDBs:

- Review the portfolio of projects related to climate change, regardless of their status (pipeline, ongoing, completed), as well as the overall portfolio of activities, including technical assistance and analytical work, in order to ensure complementarity, coordination, and consistency between the SPCR and other country programs.
- Support the GoH in the organization and implementation of the first joint mission, including technical aspects of methodological design and logistics.

Country Focal points:

- Establish synergies between the PPCR process and the project for the formulation of the National Adaptation Plan
- Identify key stakeholders, including national entities, local governments, representatives of vulnerable communities, NGOs, the private sector, as well as academia and research institutions.
- Form the high-level PPCR coordination committee for Honduras
- Convene the First Joint Mission
